Energy audit report must include assessment of usage, consumption and pattern of energy used in the premises based on all above parameters along with the conditions and benchmarks as resource and Building Envelope analysis, working, operational and Maintenance procedure analysis, Utility Data Analysis, Load Data Analysis, Analysis of energy consumption, Load Evaluation, consumption pattern, billing histor, back-up system and also the administrative requirements, assessment of safety concerns, assessment of operating and Occupancy schedules for equipments, Power Quality and Environmental Parameters Analysis, Efficiency and Wastage analysis and assessment of potential risk factors. The report must include or above data along with following points:-

- Executive Summary
- Project Overview
- Utility Analysis
- Load Profile( Details, Schedules, Matrix, Balance)
- Key Observations
- ENCONs
- Recommendations, any other
