Provision of laptops: Laptops were provided to the students through Equal Opportunity Cell of the college.

Assistance in academic matters: EOC of IHE also extended support to the member students during examinations. Student members were provided counselling on the matters related to the examinations, academics and any other college related issue through meetings and direct interaction through telephone/WhatsApp. Subject teacher and invigilators were informed that extra time should be provided to these students appearing in the examinations. Teachers involved in teaching any subject to the members of the EOC of the college were informed about the needs of the students in the class and were requested to provide individualized needed support to the students in theory as well as practical classes.
