#### SOP FOR DISCIPLINARY AND ANTI RAGGING COMMITTEE

## **Scope of the committee:**

The Institute of Home Economics Staff Council has established this committee to promote discipline among students within the college premises. The committee is guided by a Standard Operating Procedure (SOP) that outlines its role in maintaining discipline and taking appropriate action, in consultation with the TIC/Cultural Committee, to address any misconduct. It also provides a clear mechanism for addressing discipline and anti-ragging issues, ensuring a safe and respectful learning environment.

## Role and responsibilities:

- 1. To ensure that discipline is maintained within the college premises during academic sessions, promoting a conducive learning environment.
- 2. To organize awareness programs to educate students about anti-ragging guidelines, emphasizing the importance of respectful behaviour and zero tolerance towards ragging.
- 3. To obtain anti-ragging undertakings from students, ensuring they understand and commit to adhering to the guidelines.
- 4. To assist college authorities during events, functions, and activities, contributing to the smooth execution of programs.
- 5. To conduct activities, competitions, and workshops that promote good conduct, encouraging students to adopt positive values and behaviours.
- 6. To regularly update the committee's website link with relevant information, ensuring easy access to resources and updates.
