The college is inviting quotations by email/ordinary mail from reputed and experienced agencies/companies having expertise in providing EMIS solutions to academic institutions especially DU colleges. There will be a lock-in period of three years extendable as per requirement.

The broad scope of work is as follows:

- One time Application setup
- Upload/enter college data (Excel and Manual Entry)
- Generate ID no. and create sections of different classes
- Fee payment system.
- Class Attendance records.
- Internal Assessment marks entry and result processing as per DU guidelines.
- ID card generation of students and staff
- Communication system (integration with SMS & email).
- Mapping of courses with course faculty and students.
- Teaching Staff, Non- Teaching Staff and Student login portal.

Responsibilities of the service provider:-

- a) To study the user's requirements and study the detailed scope documents. Map the system and functional requirements, which include database (back-end) and programming modules (front-end) and related issues from the implementation and customization point of view.
- b) To implement the web-enabled, user-friendly, menu driven , existing application product which involves various master data input screens, transaction data input screens and processing options after approval of the in-charge of the concerned process owners, and also provide a provision to import/ export data.
- c) To facilitate backup, restoration of data, and data recovery plan and ensure data back up after every six months.
- d) To host the system on Cloud and maintain the same for the contract period.
- e) To submit the user manual along with the online help manual.
- f) To undertake customization and testing of the system in accordance to terms and conditions defined in this agreement.


