

FINANCIAL SUPPORT SCHEME (FSS) 2025-26

ELIGIBILITY: A full-time bonafide student studying in any UG/ PG Degree program at a Department/ Institution/ Centre of University of Delhi belonging to the following categories is eligible to apply. (Students enrolled in B.Tech/ Five Year Integrated Law Program are NOT eligible.)

Student with Essential Repeat (ER) in any previous examinations is not eligible to apply.

Documents Required:

1. Self-attested copy of EWS/ OBC-NCL Certificate or Annual Family Income Certificate issued by competent authority after March 31, 2025. Income Certificate signed by a notary will NOT be accepted.
2. Self-attested copies of latest Income Tax Returns (2022-23) of the following family members:
 - (a) Father
 - (b) Mother
 - (c) Sister(s) (Unmarried)
 - (d) Brother(s) (Unmarried and below 25 years of age)
3. Self-attested copy of PAN card(s) of all the above.
4. Signed copy of the Undertaking Form as per the format attached below.
5. Signed copy of bonafide certificate duly signed by Head/ Director of the Centre/ Department/ Institute as per the format attached below.
6. Self-attested copy of the mark sheet of last exam passed.
7. Self-attested copy of the latest Fee Receipt.
8. Self-attested copy of Bank Passbook showing the Student's name, Account number and IFSC code or a Cancelled Cheque.

Important:

Students must submit a copy of their Application Form and all documents after due attestation and recommendation from the Head/ Director of the concerned Department/ Centre/ Institute at DSW office.

Continuing the initiative of providing financial assistance by University of Delhi to ease students' financial challenges, the Office of the Dean Students' Welfare (DSW) announces the Financial Support Scheme for the Academic Session 2025-26. (for detailed information, visit www.dsw.du.ac.in)

Eligibility Criteria:

A full-time bonafide student studying in any UG/ PG Program in a Department/ Institute/ Centre of University of Delhi (UoD) belonging to any of the following family income category is eligible to apply. Students enrolled in constituent colleges of UoD, B.Tech. Programs (excluding CIC), Five-year integrated LAW programs, SoL and NCWEB are NOT eligible.

Category	Family income (in ₹) per annum (Eligibility)	Fee Waiver (Percentage)	Fee Waiver Limit
Category 1	Less than or equal to Rs. 4,00,000.00	Upto 100%	Actual fee or up to a maximum limit of Rs. 15,000.00
Category 2	Between Rs. 4,00,001.00 - Rs. 8,00,000.00	Upto 50%	Actual fee or up to a maximum fee limit of Rs. 10,000.00

Students with Essential Repeat (ER) in any previous examination(s) are not eligible to apply.

REQUIRED DOCUMENTS:

- 1) Copy of EWS/ OBC-NCL Certificate or Annual Family Income Certificate of the Last Financial Year (2024-25) by competent authority issued after March 31, 2025. Income Certificate signed by a notary will NOT be accepted.
- 2) Self-attested copies of latest Income Tax Returns (2024-25), if filed, of the following family members.
 - Father
 - Mother
 - Sister(s) (Unmarried)
 - Brother(s) (Unmarried and below 25 years of age)
 - Self-attested copy of PAN card(s) of all the above.
- 3) Signed copy of the Undertaking Form as per the format given on <https://dsw.du.ac.in/>
- 4) Copy of Bonafide Certificate duly signed by Head/ Director of the Centre/ Department/ Institute as per the format given on <http://www.dsw.du.ac.in>.
- 5) Self-attested copy of the mark sheet of last examination.
- 6) Self-attested copy of the latest Fee Receipt.
- 7) Self-attested copy of Bank Passbook showing the student's name, Account number and IFSC code/ cancelled cheque.
- 8) ACCOUNT DETAILS OTHER THAN THAT OF THE STUDENT WILL NOT BE ACCEPTED.
